
1) Do you have any experience with emergencies related to extreme weather events in your country?




2) Did you notice any problems during the initial phase of response to such emergencies?


- The civil protection can accommodate a number of up to 8000 people in temporary camps. The camps can be operationalized in less than 24 hours each. However, depending on the location the camps are needed, times of operationalization may differ.
- Italy has experiences many events, such as big earthquakes, in which the number of affected people was around 300/400.000 and the evacuated people of 30/35.000. The solution for people accommodation varies during the emergency from a first assistance in camps, to a long-term accommodation in hotel or temporary houses, waiting for the buildings reconstruction.



- The Federal Office of Civil Protection and Disaster Assistance (BBK) is currently executing the pilot project "Laboratory Care 5000,, (mobile care module) with the long term aim to set up the so called "Federal Care Reserve for Civil Defence". The federal care reserve is to comprise up to ten mobile care modules. With the materials of such a stored care module, up to 5000 people at a time can be accommodated and cared for at short notice, simultaneously and largely self-sufficiently for a period of up to one year. The planning basis are civil defence scenarios resulting in extensively damaged or destroyed (critical) infrastructure, high waves of refugees (consisting out of an average of the current population structure) and the arrival of such after 48 hours. As for the set up time and other relevant variables, they are to be researched within the pilot project.
- Our plans focus on use of existing accommodation infrastructure (other buildings like hotels, schools etc.) rather than building a new one.
- We have 2 ETC with the capacity 2 x 300.
- A few hours.
- 500 in 2 days.




6) Do you have any strategic plans which are dealing with the problem of long-term lack of drinking water in your country?


7) Do you have any strategic plans which are dealing with the problem of long-term lack of technical water in your country?




8) Do you have any strategic plans which are dealing with the problem of long-term lack of fire water in your country?
